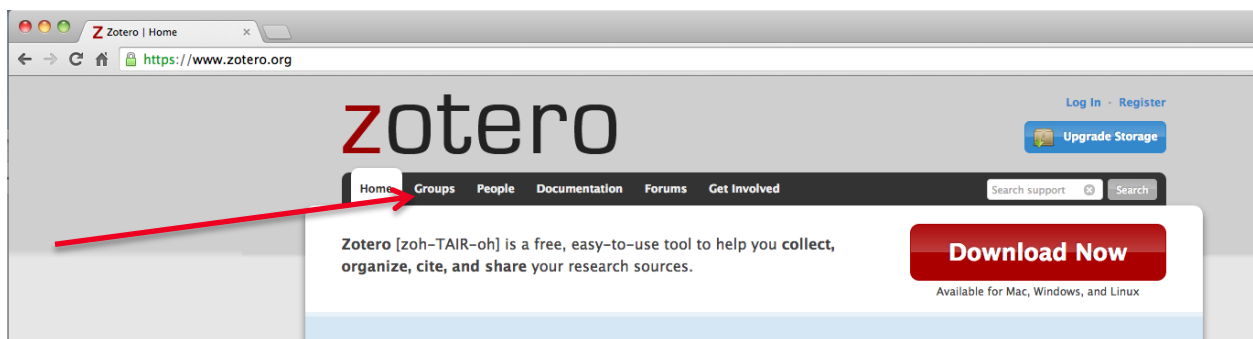

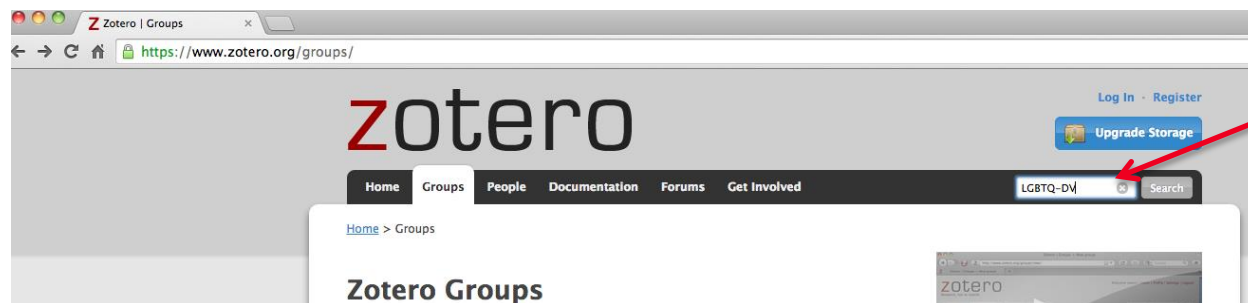
1. How do I access the Zotero Library?

Go to www.zotero.org and select Groups.

Note: You do not have to join or log into Zotero to access the LGBT-DV CBLC Library.



Once you're on the group page, type LGBTQ-DV into the search box



Once you press the "search" button, the LGBTQ-DV Learning Center Library entry page will appear. Click on "LGBTQ-DV Learning Center" to enter the library.

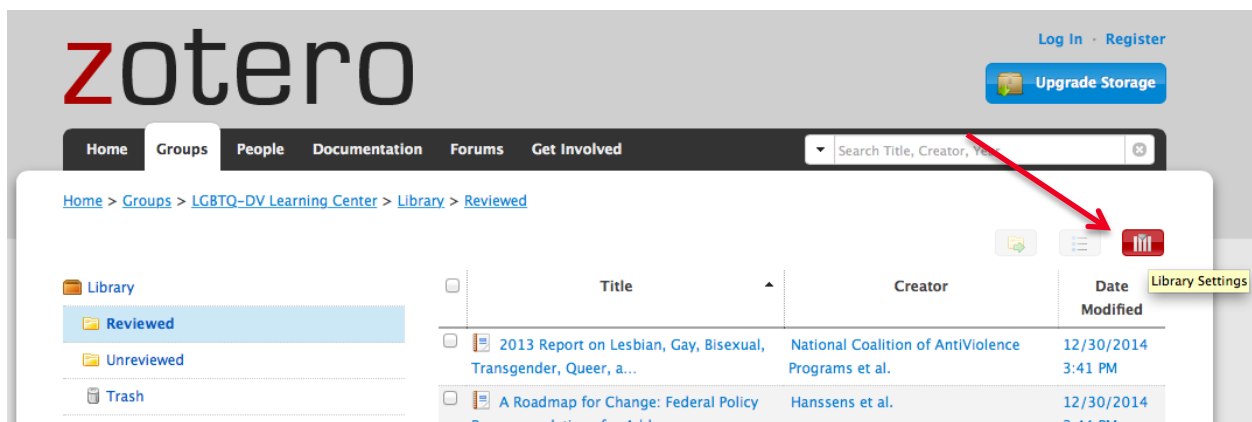


The library is organized into two folders, Reviewed and Unreviewed. Reviewed items have been assessed by LGBT-DV Learning Center staff for content and credibility while unreviewed items have not.



2. How do I sort and search for topics, specific articles, etc.?

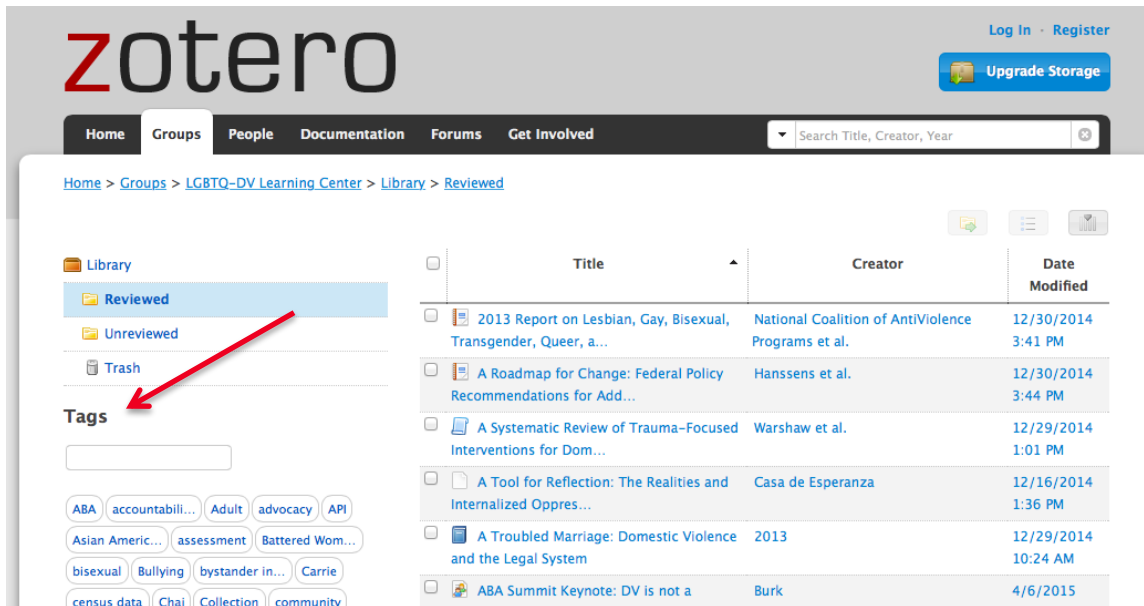
You can sort the library by title, creator, date modified, etc. You can add sorting options by clicking 'Library Settings' in the upper right corner.



Click on 'Title' to sort alphabetically by title, 'Date modified' to sort by date, etc.

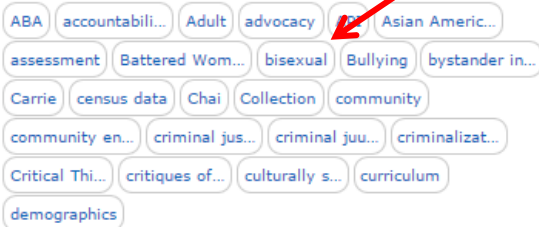


To search by topic, use the Tags option on the left side.



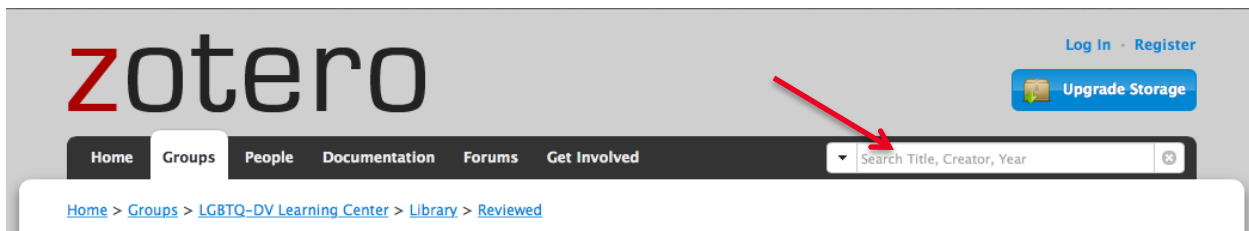
Type your topic in the search box or select from the list of tags. Selecting 'More' will allow you to see the full list of tags.



INCITE! WOMEN OF COLOR AGAINST VIOLENCE AND CRITICAL RESISTANCE: STATEMENT ON GENDER VIOLENCE AND THE PRISON INDUSTRIAL COMPLEX

Abstract (from the introduction:) We call on social justice movements to develop strategies and analysis that address both state AND interpersonal violence, particularly violence against women. Currently, activists/movements that address state violence (such as anti-prison, anti-police brutality groups) often work in isolation from activists/movements that address domestic and sexual violence. The result is that women of color, who suffer disproportionately from both state and interpersonal violence, have become marginalized within these movements. It is critical that we develop responses to gender violence that do not depend on a sexist, racist, classist, and homophobic criminal justice system. It is also important that we develop strategies that challenge the criminal justice system and that also provide safety for survivors of sexual and domestic violence. To live violence free-lives, we must develop holistic strategies for addressing violence that speak to the intersection of all forms of oppression.



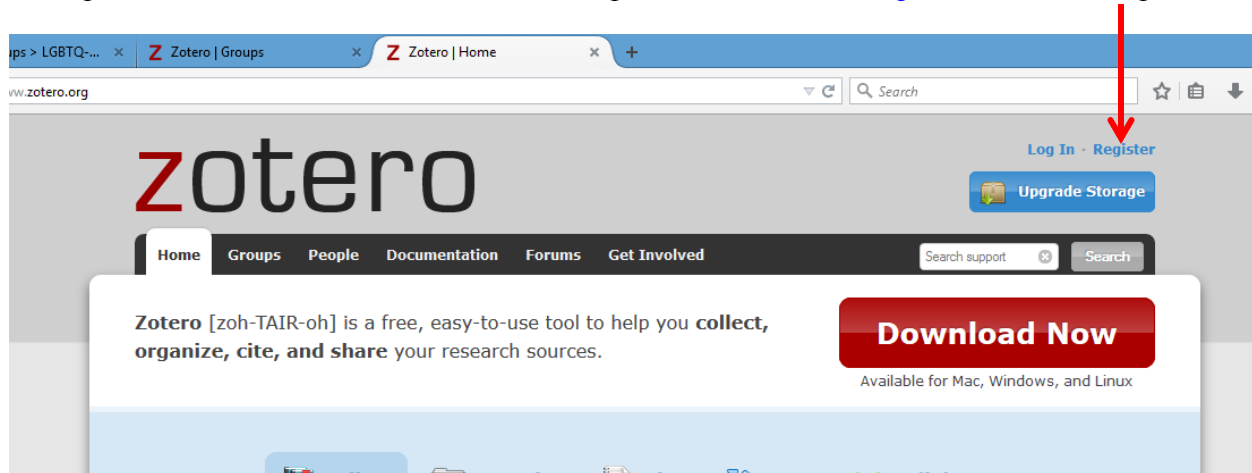

4. How do I register with Zotero and join the LGBTQ-DV CBLC Group Library?

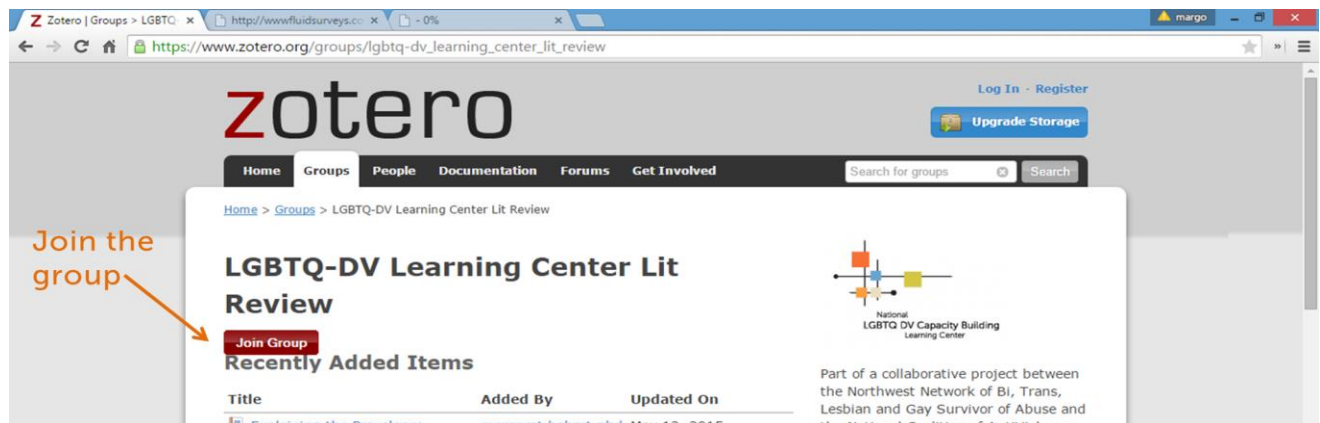
It is not necessary to join Zotero or the CBLC group library to search the literature review, find citations, and read the abstracts and CBLC commentaries. However, joining is free, allows one the advantage of being able to download PDFs directly, build one's own library and maximize the features available in Zotero.

To register (create an account) with Zotero, go to www.zotero.org and click on "Register":

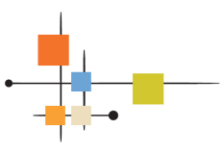


You'll be asked for your name, email and to create a password. Registration takes just a couple of minutes.

After you register, you can join the group library. Log in to Zotero, and search groups for the LGBTQ-DV library. Click on "join group."



A group administrator must accept your request to join. This may take a day or two. You will be notified when your request is accepted.

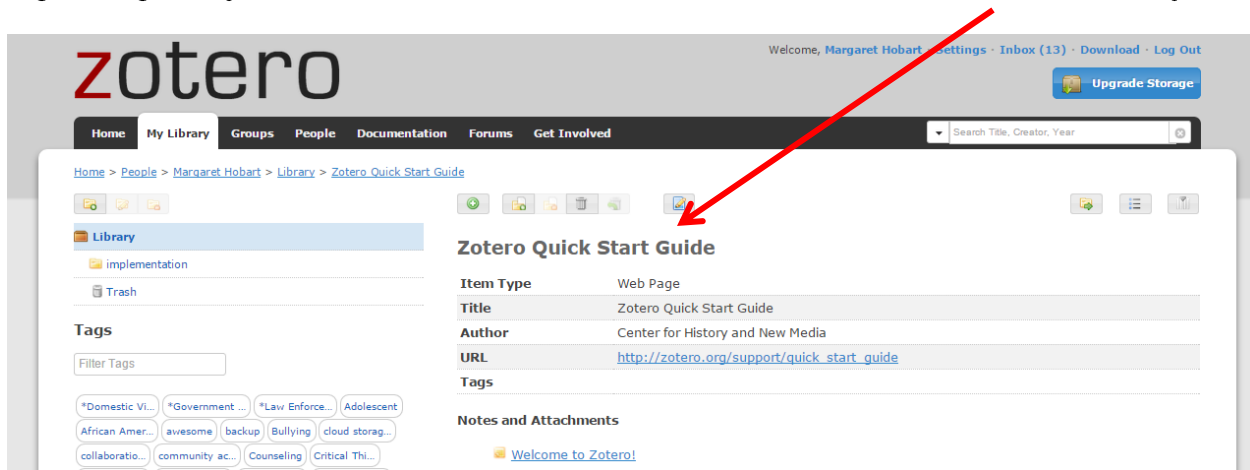


5. How can I suggest an article for inclusion in it the library?

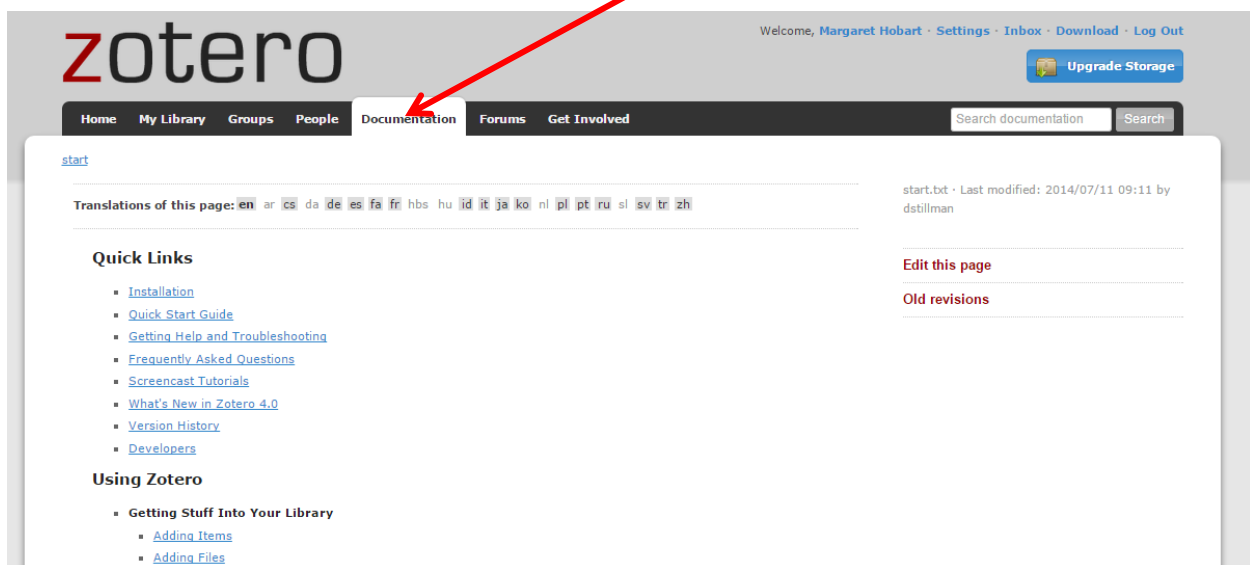

Please attach the resource in PDF form, or a link to it, if possible, and provide a brief explanation of the usefulness, strengths and/or weaknesses of the resource. We plan to update the library on a yearly or biennial basis.

6. How can I get more help with using Zotero?

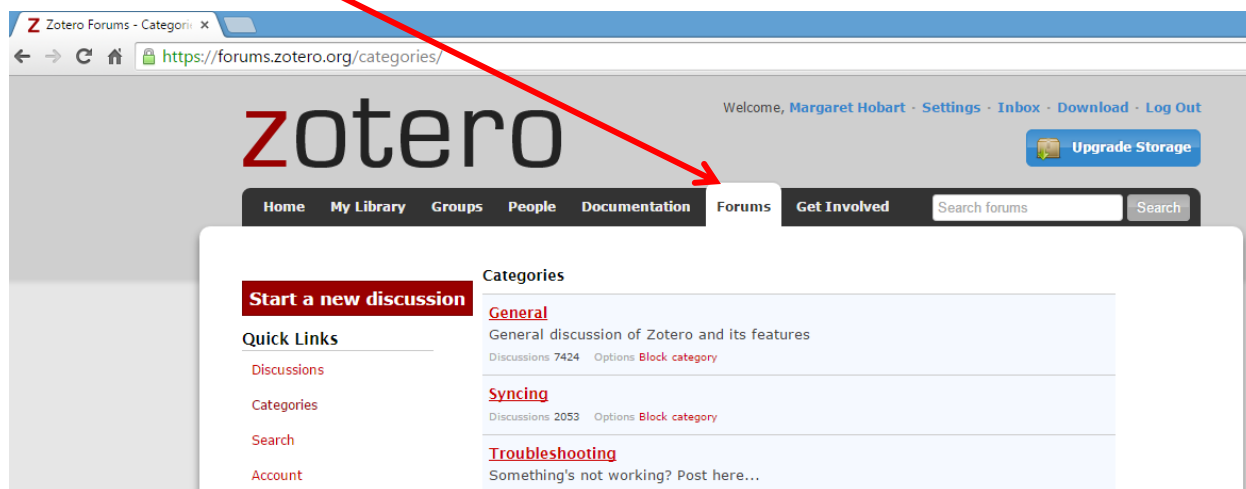
Zotero provides many features to ease tracking and storing articles, creating citations, and inserting properly formatted cites, footnotes and bibliographies into documents. Upon registering, everyone receives a Zotero Quick Start Guide as a document in their library.
