## **National Sign on Letter of Domestic Violence, Sexual Assault, and Trafficking Organizations and Programs in Support of Full and Equal Access to Services and Shelter for Transgender Survivors**

We, the undersigned 233 sexual assault, domestic violence, and trafficking organizations, strongly oppose proposed legislation and laws that limit the rights of transgender individuals. With missions to end domestic violence and sexual assault, we condemn the rhetoric that any such laws will increase safety or exist to protect women. Anti-trans laws do not increase safety and such proposals are opposed by the movement to end gender-based violence.

Though we oppose all legislation that targets the transgender community, we specifically oppose anti-transgender legislation that seeks to bar transgender and nonbinary survivors from support services and shelter spaces. States across the country have introduced harmful legislation that seeks to erode non-discrimination protections and prohibit transgender and nonbinary survivors from accessing public spaces that align with their gender identity, including restrooms, locker rooms, prison facilities, and more. These proposals seek to prohibit transgender and nonbinary people from accessing domestic violence shelters and rape crisis centers, thereby eliminating their ability to seek safe shelter space to escape an abusive relationship or healing services to recover from an experience of sexual violence.

These types of legislation are in violation of federal non-discrimination provisions in the Violence Against Women Act and Family Violence Prevention and Services Act, two primary sources of federal funding that domestic violence and sexual assault service providers rely on to provide services. Anti-trans legislation burdens service providers, forcing them to navigate contradictory laws that threaten access to federal funding.

Groups supporting anti-trans proposals claim that the proposed legislation is necessary for public safety and to prevent sexual violence against women and children. As sexual assault service providers, domestic violence shelters, and other service providers who work each and every day to meet the needs of all survivors and reduce sexual assault and domestic violence throughout society, we speak from experience and expertise when we state that these claims are false. As organizations whose missions are to reduce abuse and violence, we support laws and policies that protect transgender people from discrimination, including in accessing facilities that match the gender they live every day. We call on legislators to focus on survivors' real needs - housing, advocacy, legal support, counseling, children's services, and more.

Transgender and nonbinary individuals are already at higher risk of domestic violence and sexual assault due to the discrimination, stigma, and barriers to financial and housing security that the transgender community experiences, with transgender women of color disproportionately impacted. Transgender people already experience unconscionably high rates

of sexual assault—and forcing them out of facilities consistent with their gender makes them vulnerable to assault and abuse. Transgender people are also three times more likely to experience homelessness than their cisgender lesbian, gay, and bisexual counterparts, and eight times more likely than cisgender straight people—which speaks to the enormous need for shelters to be welcoming and affirming to transgender survivors. Limiting shelter access for transgender individuals would exacerbate this problem. Placing further legal restrictions on LGBTQ people’s access to safe shelter and supportive resources would make it even harder for LGBTQ survivors to exit abusive relationships safely and seek support in the aftermath of domestic and sexual violence.

As advocates committed to ending sexual assault and domestic violence of every kind, we will never support any law or policy that could put anyone at greater risk for assault or abuse. That is why we strongly support transgender-inclusive non-discrimination protections and oppose any law that would jeopardize the safety of transgender people by forcing them into shelters, facilities, and restrooms that do not align with their gender or excluding them from shelters based on their gender identity.

Discriminating against transgender people does not give anyone more control over their body or safety. Those who perpetuate falsehoods about transgender people and non-discrimination laws are putting transgender people in harm’s way and making no one safer. We cannot stand by while survivors, both those who are transgender and those who are not, are endangered by these laws. We will only accomplish our goal of ending sexual assault and domestic violence by treating all people, including those who are transgender, with fairness and respect.
